Outline application for erection of 1 No. dwelling

CM proposed the Parish Councill makes the following response:

The Parish Council objects to the proposed development as it would fall outside the defined development boundary and would have a negative impact on the conservation area. The Parish Council agrees with local residents' anxieties about the proposed surface water drainage impacting on properties below on North Street. Members also believe the development will add to the problematic amounts of surface run-off water into North Street, an area already prone to flooding. Further concerns revolved around the poor visibility and access onto the A352."

RW seconded. Majority in favour. 2 abstentions.

P/HOU/2021/02993 - 10 Highfield Close

Erect single storey rear extension. Extend roof to rear, convert loft into living accommodation, form sun deck and install solar panels in roof. Carry out alterations to front entrance.

TY proposed the Parish Council raise no objection. KB seconded. All in favour.

P/VOC/2021/00541 - 2 North Street

Amendment to planning permission WD/D/19/002125

JJ proposed the Parish Council raise no objection. RE seconded. Majority in favour.

P/HOU/2021/02194 - 4 Brook Close

Replace garage roof

TY proposed the Parish Council support the application subject to the plans being agreed by the conservation officer. RE seconded. Majority in favour. 1 abstention.

 CM proposed spending £250 + VAT on speed tests required by Dorset Council if they are to paint 30mph roundels on the road. TY seconded. Majority in favour. 1 abstention.
